When your child turns 18, he or she is legally an adult in Georgia and you no longer have the automatic right to make decisions for her/him. Your adult child should have an advance healthcare directive naming someone to make healthcare decisions for him/her in case he or she is unable to make or express those decisions.

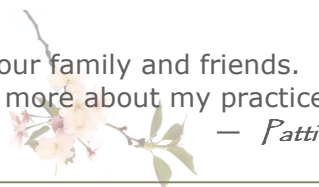
